#9 Rockbridge Park; A. Playground Equipment – Chip purchased a new swing set seat to see if it would work at the park. The seat and the chains are not as heavy as those that are currently at the park. Motion made by Chip Parduhn to authorize the purchase and installation of a comet swivel toy along with the safety surfacing up to \$2,500.00 or just purchase the toy and the needed safety surfacing and the parks commission will install all, second made by Gary Peters. The new contact for the park will be Kerry Severson.

#12 Commission member reports; Gary reported on the SW Badger RC&D meeting he attended last week.


