#8 Rockbridge Park. Nothing new happening. A water test will be done this spring before the park is opened for the season. Cathy will talk with Mike Drake regarding the trees that are over hanging the shelter.

#9 Snowmobile Alliance. Cathy went out with Paul Perkins to do an inspection of the trails before they were opened. All were marked put some of the trails were not groomed yet as the connecting County (Vernon) was not open. Cathy spoken with Anne Loechler from the state asking what would happen with the grant if the trail from Richland Center to Hub City did not get open due to landowner issues. Anne replied that if the trail is not open by April 15th it cannot be included in the grant. Discussion followed regarding use the road right of way. Cathy will be applying for a new trail from Vetesniks to Bear Valley for a grant of \$3,500.00 to get the trail ready for use.

#10 Boat Landing; nothing to report.

Grant Opportunities; Cathy handed out some information that she received in the mail. This grant opportunity needs to update the County comprehensive plan for the parks.
