- #5 Bike Trail (Pine River Recreational Trail) We did get the grant, now we need to get volunteer hours taken care of from the Symons Foundation. Drinking water in the Twin Bluffs area would be nice. Magnetic signs for trucks when work is being done on the trail. Gary Manning asked about dogs on the trail (black-top part of the Trail is part of the city and dogs are allowed. Cathy will check in with B-L signs about magnetic park commission signs for vehicles on the trail.

Gary also handed out some disturbing pictures of a shot up deer carcass. - #10 Snowmobile Alliance trails are not open at this point. Dustin Wanless will be the person to make the call as to open the trails or not.
